# "People deserve the dignity of making choices."



# Empowering Abilities

Providing services and supports to persons with intellectual and developmental disabilities.

COMMUNITY OPTIONS is one of 20 Community Centered Boards in Colorado which provide and coordinate services and supports to people with intellectual and developmental disabilities. We serve the Western Slope counties of Montrose, Delta, Gunnison, Hinsdale, Ouray and San Miguel. Major sources of funding for Community Options include the state and federal governments (primarily Medicaid), local cities and counties, grants, and private donations and fund-raising events.

COMMUNITY OPTIONS provides an array of comprehensive services to nearly 450 people with intellectual and developmental disabilities primarily in Montrose, Delta and Gunnison. People are eligible for these programs if they meet State Eligibility Guidelines. Generally, the eligibility requirements include children with significant delays in development and adults whose disability constitutes a substantial handicap attributable to mental retardation or related condition. This condition must have originated before the age of 21.

**COMMUNITY OPTIONS** delivers services either directly or through purchase-of-service contracts with other agencies or individuals. *These services include:* 

Early Intervention (for children birth-age 3) Child Development Specialists and Therapists work with parents and their child to develop activities and learning techniques which can be used in the home environment to enhance the child's development. This service is provided in the home, and in the community, as needed for each child.

Children's Extensive Support Waiver
This program provides specific targeted and
cost-effective services and supports to assist
a child with developmental disabilities and
extensive medical and/or behavioral issues to
remain in the family home, support the longterm stability of the family setting, and prevent
out-of-home placement. CES services and supports supplement natural supports and generic
community resources.

Adult Services Our Comprehensive Services program offers a wide variety of residential. vocational, and day program supports and services. Residential settings include 24-hour staffed group homes, individualized Personal Care Alternatives, and family-setting Host Homes. The Adult Day Program allows individuals to engage in supported community employment or paid vocational training in our workshops. We also provide retirement-oriented services for seniors and Community Support Services that provide an array of communitybased experiences for residents of nursing homes with developmental disabilities. Training in living skills is offered through community activities and support.

Supported Living Services offers an array of community-based services and supports for adults who live either independently or with their family.

**Transportation** Transportation is provided to and from most adult day programs and in residential and supported living, as needed.

Family Support Services Program (for eligible children and adults living with their parents) Families receive financial assistance, information and referrals, and/or services to assist in relieving the stress and extra expenditures often associated with having a family member with a developmental disability living at home.

Case Management/Service Coordination (CM/SC) This service is provided to individuals with developmental disabilities or developmental delays who are enrolled in services. Limited Case Management services are offered to individuals waiting to enter Adult Services. CM/SC coordinates services across all program and agency lines. Following the Service Plan (SP) for adults and Individual Family Service Plan (IFSP) for children and families, the CM/SC coordinates and monitors the services to ensure that the person's needs are met. CM/SC also assists in transitions to and from school programs and manages the waiting list.

Children with Autism Waiver Case management is provided for children birth to 6 years of age who meet the criteria for this waiver. There is a statewide waiting list for this service.

Administrative Services Business Operations, Property Management, Maintenance and Fleet Management across all program lines provide a financially healthy and flexible foundation upon which program services and supports may flourish.
